

PRIVACY POLICY IN ACCORDANCE WITH ARTICLE 13 AND ARTICLE 14 GDPR IN CONNECTION WITH THE LIVESTREAM OF THE GENERAL MEETING

CA Immobilien Anlagen Aktiengesellschaft, Mechelgasse 1, 1030 Vienna (hereinafter referred to as "CA Immo" or "we") processes personal data in automation-supported systems in order to be able to ensure the transmission of the General Meeting. Personal data processed in this context shall always be processed in compliance with the European General Data Protection Regulation (GDPR), the Austrian Data Protection Act, the Austrian Stock Corporation Act and the Austrian Stock Exchange Act and any other relevant legal provisions.

The following information describes how we process your personal data in connection with the live stream of CA Immo's General Meeting.

In order to be able to ensure a transmission at any time, two live streams are offered in parallel.

1. Purpose of data processing

The purpose of the data processing is the provision of a live stream for the transmission of the General Meeting of CA Immo (log creation is required for this purpose).

Furthermore, your personal data is processed in order to be able to create statistics and analyses about the use and utilization of the live stream tools.

2. Scope of data processing

Data from online live stream visitors:

- IP address of the visitor
- Browser of the visitor
- Operating system of the visitor
- Transferred bytes / bandwidth
- Duration of the connection
- Date and time of connection
- Accessed URL
- http status

3. Legal basis for data processing

The legal basis for the processing of your personal data in connection with the provision of the live stream is Art. 6(1) lit c GDPR in conjunction with Section 2(1) of the COVID-19-GesV, according to which the holding of a virtual general meeting is permitted.

The legal basis for processing your data for the purpose of creating access statistics is based on our legitimate interest in the analysis and the tool provided (Art. 6 para. 1 lit. f GDPR).

4. Duration of data storage

Your data, which we process to provide the live stream, will be deleted no later than one year after access.

Your data, which we process for the purpose of compiling access statistics, will be stored for a maximum of one year.

5. Data recipients

For the provision of the live stream, in particular for technical processing, we use service providers who process your data on our behalf (so-called "processors"). We use the following processors:

In addition, the following sub-processors have been commissioned by our named processors to provide the live stream:

In addition, data may be transferred to our subsidiary, CA Immo Deutschland GmbH, Friedrich-Ebert-Anlage 35-37, 60327 Frankfurt am Main, Germany, which we have commissioned with IT support services.

6. Your rights

As a data subject, you have the following rights: right to withdraw consent, right of access, right to rectification, right to erasure, right to restriction of processing, right to object, right to data portability and right to lodge a complaint.
